THE BERMUDA AUDUBON SOCIETY NOTES TO FINANCIAL STATEMENTS

For the year ended December 31, 2020 (Expressed in Bermuda Dollars) (Unaudited)

1 General

The Bermuda Audubon Society (the "Society") was established in 1954 with the following objectives:
a) to arouse through education public recognition of the value of and need for protecting
wild birds and animals, plants, soil and water, and the interdependence of these natural resources;
b) to cooperate, as occasion prompts, with conservation agencies and with private associations
devoted to the interests of conservation and to education in the field of natural resources; and
c) to engage in such educational, scientific, literary, historical, philanthropic and charitable pursuits as
may be a part of the aforementioned objectives.

The Society is an active advocate for Bermuda's natural environment, with special attention to bird life, and the main activities of the Society include the acquisition and management of nature reserves, education and conservation programs for Bermuda's birds and promoting the enjoyment of birding.

2 Nature Reserves

The Society owns a number of nature reserves, which are listed on an attached schedule. Over the years the costs were not recorded in the financial statements, but most were donated. All the Society's owned nature reserves have been declared inalienable i.e. they cannot be sold by the Society and must be preserved in perpetuity as open space.

3 Buy Back Bermuda

In 2004 the Society and The Bermuda National Trust entered into a joint venture initiative, "Buy Back Bermuda", to acquire and preserve public open space for the benefit of future generations. The Society has not consolidated its 50% share of the balances and transactions relating to this campaign in its financial statements. However the transactions have been audited by the auditors of The Bermuda National Trust, as their share is consolidated in their audited financial statements. At December 31, 2020 the following figures, being the Society's share, are not included in these financial statements:

- 4 Alfred Blackburn Smith Reserve Fund
 - The Society received a cash donation in 2014 to be used specifically on the Alfred Blackburn Smith Reserve in Paget. The property is adjacent to the Coral Beach Club. Work on removing invasive trees and shrubs is ongoing.
- Investment Bermuda Community Foundation Endowment Fund
 Bermuda Community Foundation had a Matching Funds Program in 2014 and charities were challenged to compete for a \$5,000 match (from RenRe) with the establishment of a \$20,000+ endowment fund. The Society applied and were awarded a grant in early 2015 and so contributed \$20,000 of its funds, for a total of \$25,000. At the end of December 2020 the value of the total fund for the Society was \$29,669 (2019 \$27,636).
- 6 Bermuda Birds Photographic Guide Project

Donations were received in 2018 in honour of Andrew Dobson's contribution to the Audubon Society, to fund his project to produce a Photographic Guide to the Birds of Bermuda. Silent auction proceeds from Andrew Dobson's farewell dinner were also added to this fund.

- 7 Membership Fees
 - At the May 2018 Annual General Meeting it was agreed to change membership to calendar annual renewals. As such 2019 versus 2018 membership fees levels reflect that 2018 memberships were not renewed as was previously the custom at mid year but deferred instead until the start of 2019. Membership levels in 2019 were also high due to the take-up of several Life time memberships.
- 8 Legal Fees In conjunction with a closed legal matter, in 2019 the Society was refunded \$2,500 in excess retainer.
- 9 Nature Reserve Costs

In 2020, the Society carried out a major renovation project at Somerset Long Bay West Nature Reserve, to remove, invasive vines that had smothered and killed a number of trees, and to remove large areas of invasive Cow Cane. Professional landscapers were employed to remove Cow Cane, vines and dead trees with a backhoe, to regrade the surface and conduct follow-up removal of regrowth. The fencing was also repaired.
